


- Distributed in November 2024 to January 2025

Percentage of Departments Offering Faculty Training




Percentage of Departments Offering Faculty Training



Percentage of Departments Offering <u>Staff</u> Training




Percentage of Departments Offering <u>Trainee</u> Training




Percentage of Departments with <u>Mandatory Faculty</u> Training







- Decrease in the percentage of departments including race and ethnicity in evaluating faculty turnover
- Almost 1 in 4 departments have stopped or limited their diversity, equity, and inclusion (DEI) practices since the 2023 Supreme Court decision






Is your institution private or state-funded?
