Joan Alker, MPhil

Joan Alker is Executive Director and Co-Founder of the Center for Children and Families (CCF) and a Research Professor at the Georgetown University McCourt School of Public Policy. A nationally recognized expert on Medicaid and the Children's Health Insurance Program (CHIP), she is the lead author of CCF's annual report on children's health care coverage trends. Alker has published in journals such as JAMA and Health Affairs, and has written extensively on issues including Medicaid Section 1115 waivers, rural health, child and family policy, and premium assistance, including multiple reports for the Kaiser Family Foundation.

James Perrin, MD

James M. Perrin, MD, is Professor of Pediatrics at Harvard Medical School and former Director of the Division of General Pediatrics at MassGeneral Hospital for Children, where he also founded the Center for Child and Adolescent Health Policy. A past president of both the American Academy of Pediatrics and the Academic Pediatric Association, he has long focused on health care for children with disabilities and Medicaid policy. Dr. Perrin has collaborated with Massachusetts Medicaid to expand coverage and access, and has published over 250 articles, chapters, and commentaries. He was the editor of the 2024 NASEM report Launching Lifelong Health by Improving Health Care for Children, Youth, and Families.





Edwin Park, JD

Edwin Park is a Research Professor at the Georgetown University McCourt School of Public Policy and a leading national expert on Medicaid, CHIP, and the Affordable Care Act. His work focuses on federal and state health financing, including Medicaid expansion, provider taxes, and drug pricing. Park previously served as Vice President for Health Policy at the Center on Budget and Policy Priorities and held senior roles at the White House National Economic Council and the U.S. Senate Finance Committee. He has testified before Congress and regularly contributes to national media coverage. He is a member of the National Academy of Social Insurance.
